TERMS AND CONDITIONS

THERE WILL BE NO SMOKING AND/OR VAPING ANYWHERE ON THE PREMISES

- 1. The Oshawa Naval Veterans' Club will not be responsible for any personal injury, damage or the loss or theft of personal clothing, equipment, or any other items.
- 2. The renter agrees to pay for any and all damages incurred to furniture, memorabilia and premises. (A \$100.00 damage deposit is required prior to the event). If credit card number was provided, card may be billed for damages.
- 3. The renter agrees to indemnify the Oshawa Naval Veterans' Club for all costs and awards associated with any civil action resultant from actions of their guests, invited or otherwise.
- 4. The lessee is responsible for seeing that the premises are vacated no later than thirty (30) minutes of the legal closing time. For alarm purposes, all decorations must be removed from ceiling and walls the same night.
- 5. No alcohol is to be sold or served to minors under any circumstances.
- 6. No alcohol will be sold or served outside the agreed times.
- 7. Absolutely <u>NO alcohol other than that obtained from the Oshawa Naval Veterans' Club</u> is allowed on the premises.
- 8. All alcohol is to be consumed on the premises and none taken outside. IMPORTANT NOTE: loss of damage deposit and/or immediate termination of function will occur if not compliant.
- 9. At the time of signing this contract, a minimum deposit of \$100.00 plus HST is required to be paid to the Oshawa Naval Veterans' Club.
- 10. The balance of all monies owing including the \$100.00 plus HST damage deposit must be paid in full no later than thirty (30) days prior to the rental date.
- 11. Failure to comply with these terms and conditions may result in cancellation of this contract including the loss of services contracted for and the forfeiture of any monies paid.

CANCELLATION AND REFUND POLICY

- 12. Cancellation of an accepted rental Contract must be made in writing to the Hall Rental Chairman.
- 13. In the case of a cancellation prior to thirty days (30) in advance of the date of rental this deposit will be returned only if the Oshawa Naval Veterans' Club is able to re-rent the hall for that date. If the hall is not re-rented or the cancellation is made less than thirty days (30) before the rental date, the renter shall forfeit the deposit.

GALLEY POLICY

The galley must be <u>left in a clean and tidy condition</u>. If left untidy, ONVC staff will be used to tidy up and a deduction made from the damage deposit.
